ALL STAR JUNIOR NETBALLERS CLUB CONSTITUTION

1. Name

The name of the organisation shall be **ALL STAR JUNIOR NETBALLERS** hereinafter referred to as the 'Club'.

2. Objectives

The club is established to pursue the following objectives:

The organisation, management and development of NETBALL for all members of the Club.

The provision of training and playing facilities for its members.

Promoting and maintaining the highest standards of technical competence and safety in the sport. Upholding the rules of the sport.

Providing equality for successful participation by all sections of the community The promotion of the sport of Netball.

3. Affiliation

The Club shall be affiliated to NETBALL SCOTLAND.

4. Membership

All members are subject to the Constitution of the Club and the regulations of the NGB.

Membership of the club is open to all individuals, in a defined age group, provided they comply with this Constitution.

No person shall be refused membership on the grounds of marital status, sexuality, employment status, social class, colour, race, ethnic or national origin, religious belief or disability.

All applications for membership shall be accompanied by the appropriate annual membership fee, which shall thereafter be payable on demand.

Members shall be enrolled on one of the following categories: (Examples)

- i) Playing/Competing Member (adult/junior)
- ii) Non Playing/Associate Member (non competing)
- iii) Coach (qualified)
- iv) Official (qualified)
- v) Volunteer/Helper
- vi) Junior Member
- vii) Life Member

5. Suspension, Refusal or Termination of Membership

The Management Committee shall be entitled to:

Refuse any application for membership on the grounds that such membership would be prejudicial to the objectives of the club as set out in Rule 2 of this constitution.

For good and sufficient reason refuse renewal of any existing membership or terminate or suspend any membership provided that the member concerned shall have the right to be heard by the full management committee before a final decision is made.

The member may apply for reinstatement at the next general meeting.

Any member who fails to pay his/her fees by the date required shall forfeit his/her right to representation on the management committee and at general meetings, and shall be suspended from taking part in any event under the control of the club until such fees are paid.

Any member under suspension shall be barred from taking part in any match or event under the control of the club.

The management committee shall inform the member in writing of any decision to terminate his/her membership.

Notification of the termination of a membership will be forwarded to the Governing Body.

6. General Meetings

Annual General Meeting (AGM)

The AGM shall be held each year at such time and place as determined by the management committee, at approximately twelve monthly intervals, but no more than fourteen months after the date of the previous AGM.

At each AGM the following business shall be conducted:

- i) Receive and confirm the minutes of the previous AGM.
- ii) Presentation of the clubs financial accounts for the year.
- iii) Presentation of clubs projected financial situation for the forthcoming year, and the setting of all fees.
- iv) Presentation of Chairpersons report.
- v) Election of office-bearers/committee members to the management committee.
- vi) Any other business brought before the meeting that has been submitted in writing to the secretary not less than seven days prior to the AGM, and any other business deemed relevant by the chairperson.
- vii) Notice for an AGM shall be a minimum of 21 days.

b) Extraordinary General Meeting (EGM)

An EGM may be called upon the written demand of:

- i) 33% of the membership.
- ii) The Chairperson.
- iii) 2/3 majority of the management committee.

iv) Notice for an EGM shall be of a minimum of fourteen days notice, and stating the business to be discussed.

8. Members of the Management Committee

- a) The Management Committee may consist of the following Office-bearers/Committee members:
 - i) Chairperson
 - ii) Secretary
 - iii Treasurer
 - iv) Team Managers/Coaches representative
 - v) Child and/or Vulnerable Adult Protection Officers

11. Finance

The income and property of the club, however derived, shall be applied solely towards the objectives of the club as set out in Rule 2, of this constitution.

The club shall have the power to raise money by means of yearly affiliation fees and match fees as determined by the Management Committee at the Annual General Meeting.

All monies shall be lodged in a bank account in the name of the Club.

The Treasurer and Secretary shall be authorised signatories to sign cheques on behalf of the club, of which two signatories shall be needed.

The financial year of the club shall run from JUNE to JUNE.

12. Amendments to the Constitution

This Constitution may only be amended by a proposal passed by a two-thirds of members present and entitled to vote at an Annual or Extra Ordinary General Meeting.

- 13. The Dissolution of The Club
- a) Any resolution to dissolve the club may be passed at any General Meeting provided that:
 - i) the terms of the proposed resolution are received by the Secretary at least forty two days before the meeting at which the resolution is to be brought forward, and that
- ii) at least twenty eight days of the proposed resolution shall be given in writing by the secretary to all members, and that
 - iii) such a resolution shall receive the assent of two thirds of those present and entitled to vote and that
- b) Upon dissolution of the Club, after all Club and Trustee liabilities have been cleared, all remaining financial and material assets shall be given or transferred to the local East Renfrewshire clubs/league, as determined by the meeting, to be employed for the development of the sport.
